He has been active in the UK EMV programme since 1994 and in the Chip and PIN at Point of Sale migration. This resulted in his secondment to the UK Chip and PIN Programme Management Office in 2002 as assistant to the Technical Director.

Nick has extensive knowledge of and involvement with the UK Association for Payment Clearing Services standards [APACS60 (editor), APACS30/40 & APACS70 (past chairman) and APACS50/29 (past deputy chairman)].

He has presented the UK EMV Experience at seminars in the UK, Athens, Dublin, Sofia, Istanbul and Bahrain. As a Consultant within Barclaycard Merchant Services he supported internal teams and retailers in preparation for EMV.

Nick, in co-operation with Vodafone, is responsible for the development of the electronic mobile phone top-up concept and subsequent service. He was also responsible for designing and developing Barclaycard Business' Dynamic Currency Conversion terminal application.
